Mr.Luhar,

You are appointed as **Assistant Professor in Economics against the Reserve Post for S.E.B.C. Category** under Vertical Range of Pay Level Rs.57,700/- to Rs.1,82,400/-, Academic Level-10 per month on probation for a period of two years. You will be entitled for Allowance as per the rates prescribed by the State Government from time to time and accepted by the University. In addition you will be entitled for New Defined Contributory Pension Scheme only.

Your appointment to the above post is subject to the following conditions that:

- (1) Your duty will be to work under the instructions of the Head of your Department of University; and
- (2) Your confirmation to the said post will depend upon your interest in research of approved standard; and
- (3) You shall abide by the service conditions and code of conduct prescribed by the University from time to time; and
- (4) Physical presence in the Department as per the timings prescribed by the authorities and if need be, putting in extra hours of work on all days including holidays without remuneration; and
- (5) Should not accept any remuneration for any work done, for any agency/ institution / individual without prior permission of Sardar Patel University through proper channel; and
- (6) Not to engage directly in trade or business or any private tuition or undertake any employment other than your official assignments; and



- (7) Should maintain confidentiality in the work of the Department and shall not reveal either orally or in writing to any other person without prior written permission of the University; and
- (8) You will be required to enter into an agreement with the University on assuming charge of your office.
- (9) You will be required to produce relieving certificate, if appointed on Permanent Post at present and hold employment from your present employer before joining.
- (10) You are further informed that you have to join duties within a period of **ONE MONTH** from the date of issue of this appointment order, failing which the appointment order is liable to be cancelled/ withdrawn and shall automatically be considered as null and void.
- (11) You will have to abide by the rules/regulations/guidelines/ Government Resolution about the requirement of Passing the CCC/CCC+ (Course on Computer Concept) examination/Hindi Examination/ Gujarati Proficiency test during your probation period as amended from time to time.
- (12) You will be required to produce a fitness certificate from Government Medical Officer, through Medical Officer, University Health Centre, Sardar Patel University, Vallabh Vidyanagar.

Your appointment is based on the information supplied by you in your application. If during your tenure at any period of time, information supplied is found to be incorrect, your services will summarily be terminated and University will take legal action against you.

You are requested to intimate this office within ten days from the date of this letter of your acceptance of the appointment and the probable date of joining duty.
